The committee asked for a white paper outlining a new name for Foreign Direct Investment (FDI) and various buying options for \$750 thousand, \$1 million, and \$1.5 million for FDI investment for the state of North Dakota.

Chairman Leiman addressed the use of the buying options, soliciting of new buyers for new products, and the location of finding value added production for North Dakota companies.
